2. Competition is open to residents of Victoria.
3. Entrants must be aged 18 years and over.

5. A permit is not required for this competition under Victorian law.
6. Tickets purchased between 9.00 am on 30 January 2026 and 11.59 pm Thursday 2 April 2026 will automatically be entered into the draw. Prizes will be drawn and winners notified two days before the event. Winners will be notified and will be contacted by Guide Dogs VIC via email to organise the prize experience which will be provided on the day of the fair (Saturday 18 April 2026).
7. It is a condition of entry into the giveaway for the entrants to provide Guide Dogs VIC with a valid email address for the notification of prizes. Entry will be void if contact details are missing or invalid. Guide Dogs VIC reserves the right to verify entry validity (including identity, age and residence) at any time and reserves the right to disqualify individuals deemed to have breached these Terms and Conditions, in its sole discretion.
